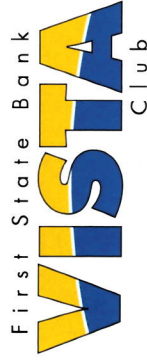

### WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

FOR AND IN CONSIDERATION OF being permitted to participate in the First State Bank Vista Club (Senior Travel Club), being fully advised and acknowledging the inherent danger of these activities, I on behalf of myself and my heirs, executors, administrators, attorneys and assigns, hereby waive, release and forever discharge First State Bank, its officers, agents, and employees, past, present, and future, and each of its and their respective successors and assigns (hereinafter collectively referred to as "Releasees"), from any and all known or unknown actions, causes of action, claims or liabilities of any kind which have or could be asserted against the Releasees arising out of participation in the First State Bank Vista Club (Senior Travel Club).

I FURTHER UNDERSTAND THAT THIS WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT INCLUDES A RELEASE OF ALL KNOWN AND UNKNOWN CLAIMS.
