Cancellation Policy: Individuals who cancel their reservation before December 16, 2026 will receive a refund of \$350. The following is in addition to the \$400 non-refundable payment for Travel Insurance that is part of the initial deposit: individuals who cancel their reservation between December 16, 2026 and July 14, 2027 will be subject to a cancellation fee of \$350; between July 15 - August 14, 2027 the fee will be \$1,000; between August 15 - September 14, 2027 the fee will be equal to 50% of the price of the trip. No refunds can be given to individuals who cancel their reservation after September 14, 2027 or for no-shows. *For individuals who choose not to include Travel Insurance, their cancellation fees are: cancel before December 16, 2026 and receive a full refund of deposit; cancel between December 16, 2026-July 14, 2027 = \$350 fee; between July 15-August 14, 2027 = \$1,000 fee; between August 15-September 14, 2027 = fee of \$50% of their price for the trip; after September 14, 2027 and for no-shows = no refund.*
